Accordingly all Retirees were asked to submit an online form giving the contact details-

In this connection we would like to highlight certain issues.

A. NON RECEIPT OF CONFIRMATION /ACKNOWLEDGEMENT

- Many retirees have filled and submitted the online form.
 But no one received any Acknowledgement mail or SMS confirming receipt of the data.
- 2. Probably you may be aware that the majority of the Al Retirees are very Sr. Citizens of 70+80+85 of age.

3. Majority are not tech- savvy and are not experienced in filling up such online forms correctly and saving in

PDF format etc.

4.Under such circumstances, one is not sure whether the form has been received at your end or not.

5.In the absence of any confirmation from your end ,many have resubmitted , but no acknowledgement .

Hence we humbly request you to look into this urgently and arrange to send to CONFIRMATION mail or SMS or publish a list of those whose data have been received.

- B. Need for extension of the last date for submission
- 1. The last date for submission, ie10.10.23 is too short a period to reach the communication to all retirees.
- 2. Many are hospitalised and it is not sure whether they received the information at all.
- 3. Many do not have Mail IDs / Smart Mobile phones / Whatsapp facilities.
- 4. Many are staying in remote villages or may be abroad.
- C. Ambiguity in the format
- 1. The Name column needs more clarity for filling
- 2. Ambiguity exists in the case of spouses of deceased employees. Though some clarifications have been

seen on whatsapp groups by someone, No official clarifications from your end have been seen .

We welcome and appreciate your intention to implement the revised Passage Policy in the digital platform at the earliest.

But at the same time in that process, as the Head of Employee Relations,

it is our request to you to ensure to take all retirees on board

and justice meted out to all who are at the fag end of their lives.
