Cbwai went ahead in arranging vc meeting on 11.10.2023 with all concerned which was chaired by Respected AD, Mumbai.

The deliberation and decisions are listed below:

Mr Shantisagar put on records following points, to the queries of beneficiaries:

1. Bills raised for treatment are cleared in queue, first come basis.
2. Bills submitted till 20.9 .23 where there is no objections are cleared and it will take about months time to credited in beneficiaries account.
3. He asked all beneficiaries and hco to update bank account details in portal.
4. He further stressed there is no budget hold ups. Any specific cases, whose bills are stuck should approach him.
5. In future it was assured by aiahl and utissl, that sms of bill clearance shall be installed.
6. He, further confirmed for fresh bills submissions the process of verification for bills will be 15days and clearance 30 days. Any delays, may be posted to him.
7. A fresh training for all hcos who missed or desirous of taking trg for cashless bill submissions, date of training fixed is coming monday.

8. All beneficiaries desirous of getting empanelled hco for trg can ask hco to give mail to aiah and utissl, they have been briefed.

9. For, all bill related issues, delays please send mail to Mr shantisagar and follow up.

10. Point regarding, trained hco denying cash less treatment to beneficiaries

Dr mondal, AD, had earlier instructed Hcos about action initiation against those hco for refusing cashless treatments

11. He once again, warned strong action yesterday against hco refusing cashless treatment. He also brought out that in this connection letters of cghs, delhi has to be followed. He further, brought out, that any cases of refusal of cashless treatment by hcos to brought out by beneficiaries to his office, without fail.

He also, assured to look after other points, which are in his ambit, for this a list of points are requested from all, to be posted in this app, cbwai will take up jointly.
